3. **All horses, except weanlings, entered into a futurity or stake must also enter at least one APHA class (any class) at the Harvest of Colors Show. Failure to do so will cause any futurity payment to be forfeited.**
4. **Weanlings not entering an APHA class must include the \$50.00 office charge with futurity entry.**
